- Comments: Due to uncertainty around payment timing from Fontaine, we decided to spend less than approved on signs. All street signs were made and installed. Only 5 of 10 “Welcome / No Trespassing” signs were made. 1 “Roosevelt Ridge Arrow” sign was made.

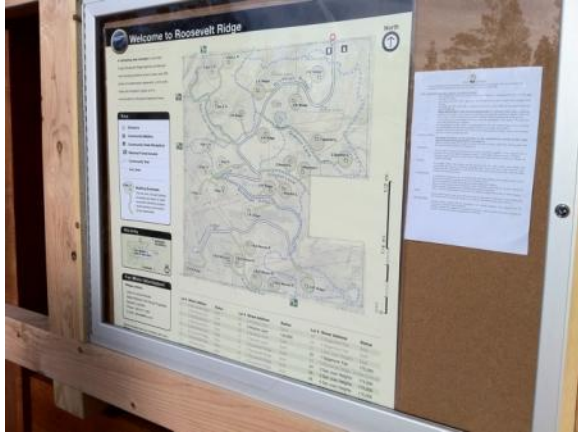
